Your employees can sign up for this extra layer of protection at no extra charge. This offering helps them know what's going on with their credit activity. In addition to credit and identity theft monitoring, they'll get:

- Identity repair.
- An identity theft insurance policy (up to \$1 million).
- ChildScan for minors (databases are scanned to detect unauthorized use of a child's Social Security number).
- An annual credit score and credit report (on request).
- The ability to set, renew and remove 90-day fraud alerts on their credit file to help protect them from fraud.

How to get started

To get all the great benefits of AllClear's credit and identity theft monitoring, your employees can go to **anthemcares.allclearid.com** and submit their name and email address. Next, they'll get an email with a redemption code and instructions on how to create an online account. They'll provide their name, contact information, Social Security number and the redemption code. They can also sign up by calling 1-855-227-9830, Monday to Saturday, from 8 a.m. to 8 p.m. Central.

Once they're enrolled, they'll get alerts when banks and creditors open new accounts in their name. They'll also be alerted if any of their personal information is reported by security professionals — including the Federal Bureau of Investigation (FBI). This includes their Social Security number, credit card numbers, bank account logins and more.

At any time, if something doesn't seem right, they can contact AllClear ID for help.
